### STANDARDS

As a collective, we believe in identifying minimum requirements for External Service Providers (ESPs) that exceed the minimum requirements for CUI protection as defined in DFARS 252.204-7012 / NIST SP.800-171.

- ✓ A NIST Cybersecurity Framework (CSF) Profile for ESPs
- ✓ A NIST SP 800-53 Tailored Baseline for ESPs
- ✓ Suggested changes to standards such as SP 800-171

### APPROPRIATIONS

We understand that proposals that have been submitted to Congress which include DoD appropriations for grants to DIB members to offset the necessary one-time investment in getting the DIB to CMMC compliance. The MSP Collective supports this effort and will continually seek new ways to support critical infrastructure
